Easton Day Sun., Sept. 10, 10 a.m. Genocide Survivor to Speak



Easton Day is the annual commemoration of the 1777 Feathers of Peace incident when a party of Burgoyne's Native Americans set aside hostilities and joined Easton Friends in worship. This year features "Out of Genocide, a Drive for Peace," a talk by Amminadab Munyaneza, founder of the Outposts of Chat Network. Mr. Munyaneza and his family survived the Rwanda genocide and came to the United States, where he earned a Masters degree in conflict resolution. He was recruited by the UN for peace-building missions in Kosovo, and then in Uganda and Nepal. (continued)

Easton Day (cont.)

He and three other U.N. representatives in Kosovo saw TV images of the destruction of the World Trade Center. He wrote, "[We] could not understand the way Islam was being portrayed. The media did not differentiate between Islam as a peaceful religion and the acts of terrorists who have nothing to do with Islam as a religion. Religion Without Borders was formed by the four of us as a protest, to provide information about Islam." He also started chapters of Religions Without Borders in Uganda and Nepal. After returning to the U.S., the name was changed to Outposts of Chat. Bill Reagan, of the Easton Quaker Meeting, said. "This is a stellar example of international Quaker peace work."

All are welcome to Easton Day which includes 10 a.m. registration, 10:30 a.m. Feathers of Peace story and Meeting for Worship, with a concurrent program for children. Clearness Committees

Ministry and Nurture Committee feels led to bring an important Quaker asset to the attention of Albany Meeting attenders and members: Clearness Committees. They represent a process for discernment which are an often overlooked method of bringing clarity and comfort when we are struggling with a decision or concern, seeking to reach a solution on how to respond to a dilemma. Like Quaker business meeting, Clearness Committees are considered a form of Meeting for Worship and are based on the principle that the Inner Light is present in us all; the process aids the person seeking clearness to find the "answer within" rather than offering outside advice or guidance.

A Clearness Committee can be requested by anyone for any reason and will usually be appointed by one of the standing committees of the Meeting. A Clearness Committee can help you to learn the nature of asking open and honest questions, to experience how everyone has an inner teacher, and to see what happens when we commit to the ideas of "no fixing, advising, saving or correcting one another." It is simple and demanding. Done well, it is a positive experience for all involved. Deep understanding of the practice and careful preparation of the focus person and committee members is essential.

If you have a concern or troubling situation that you would like to bring to this time honored Quaker method of relief, please speak to a member of Ministry and Nurture. The power of the Spirit coupled with abiding Love can bring new life and clarity to any heart breaking or darkened dilemma. I will announce this renewed emphasis at Meeting on September 3. A Dangerous Thing

A little knowledge is a dangerous thing. So the old saying goes. Perhaps there's more than a kernel of truth in those words...at least in the eyes of the Israeli government.

On Monday, the 21st of August, those of us who support the human rights of Palestinians celebrated the news from UN Human Rights Officer in Hebron, Hamed Qawasmeh, that work on the new, pre-fab school building in the village of Jubbet Al Dib (Jub a-Dib) had been completed. Supplies, furniture and equipment were being moved in.

Two days later, the sun set on the aspirations of parents in that Palestinian village southeast of Bethlehem. Hamed wrote that Israeli government forces "numbering more than 100 soldiers" were "dismantling the school." On what was the first day of the new school year in Palestine, 80 children saw the Israeli army dismantle their new school. All that remains is the foundation.

According to the Israeli Human Rights group, B'TSELEM, on the 21st of August, in the Palestinian village of Babu al-Baka near Jerusalem, a force of around 50 Israeli soldiers, police and border police dismantled and confiscated a pre-fab building that was to serve as a kindergarten for children in that village. Desks, chairs, cabinets and a blackboard that had been brought to the school building three weeks prior were also confiscated by the Israeli forces.

We remain hopeful that the Sumud (inner strength and steadfast, non-violent resistance) of the Palestinian people will continue and -- in spite of our government's substantial financial and political support of the Israeli regime's racist policies and often brutal actions -- will prevail. May the day soon come when Palestinian rights are recognized and supported by the people and governments of Israel and the United States of America.

Friends approved the 2017 slate of Trustees.

The first reading of the slate for all other committees was presented (attached in meeting minutes.) Several clarifications and corrections were discussed; the committee will follow-up and report again at the July Meeting for Business. The final approved slate will be attached to the minutes at that time. **Ministry and Nurture:**

The committee reported there were two requests approved for financial assistance to attend Silver Bay. **Peace and Earthcare:**

The Committee reported on a letter sent to Clerk of Albany Friends Meeting from Quaker Palestine-Israel Network. The letter was in response to the AFM letter to Friends Central School regarding the cancellation of a presentation by Palestinian Professor Sa'Ed Atchan and subsequent dismissal of two faculty who supported the student group that invited him to speak. The Quaker Palestine Network letter described some actions the organization is undertaking. Friends suggested some additional follow-up we might take on, including further outreach to New York Yearly Meeting and a minute on our concerns regarding Palestine and Israel.

The Meeting closed with silent worship at 12:25 p.m.

Peace and Earthcare:

In order to save on electricity, save the environment, reduce global warming and have the flexibility to support low to moderate income people with purchasing solar energy, members of the Peace and Earthcare Committee recommend Albany Friends Meeting establish a working group to explore the vision of participation in a faith based solar community energy co-op with other faith communities. This recommendation is based on several committee members' participation in a four month process of educational sessions. After a brief period of discussion, Friends approved this request. Lawrence Eger, David Barnard and Sheree Cammer agreed to be on the working group.

Paul Rehm Provided information about the current conditions in Palestine and presented the following minute for the Meeting to consider:

Minute on Palestine/Israel

Turning to Advices and Queries in NYYM's Faith and Practice, we note that "Friends are advised to work toward removing the causes of misery and suffering. They are encouraged to bear testimony against all forms of oppression." Albany Friends Meeting recognizes the Israeli government's oppressive practices (viewed by President Carter and Arch-Bishop Tutu as meeting the definition of Apartheid) during its 50-year military occupation of the Palestinian Territories as causative factors in Palestinian suffering.

Reflecting on Friends' history of working to alleviate suffering and improve conditions in Palestine and Israel since 1860, and believing that peace with justice is attainable for Palestinians living in the Occupied West Bank and Gaza as well as for Jewish and Palestinian citizens of Israel, and confirming our support for that goal as well as an end to military occupation, Albany Friends Meeting calls for:

- all parties to renounce violence in pursuit of their objectives;
- all parties to recognize and comply with all UN Resolutions relating to Israel and Palestine;
- free, internationally monitored elections in the West Bank and Gaza with guarantees from all UN member states that they will abide by the results of those elections;
- free entrance to and egress from Gaza and for Palestinian refugees to be given the Right of Return as guaranteed by UN Resolution 194.

Albany Friends Meeting also calls on the Israeli Government to:

- transfer all Israeli settlers out of West Bank settlements (which are illegal under International Law), or allow all parties equal and unfettered access to those settlements under control of the Palestinian Authority or of an independent, neutral body for a period of 50 years;
- modify existing Israeli laws and regulations so all parties are subject to equal requirements and restrictions and face equal penalties for violations of those laws and regulations;
- dismantle the segregation wall in accordance with the International Court of Justice's 2004 advisory opinion and to allow all parties equal access to the natural resources (including water) of the region as well as to all roads and to all public transportation;

Furthermore, Albany Friends Meeting accepts the 2002 Triennial Session call of Friends United Meeting "to work with other Christian bodies...to find ways together to work for peace, justice and reconciliation" in Israel/Palestine.

After Friends asked questions, raised some concerns and spoke of many Friends organizations long work on this issue the minute was approved. Sheree Cammer and David Barnard asked to stand aside. The minute will be forwarded to Regional Meeting and NYYM.

Peace and Earthcare provided background information about the case of arrestees from the January 20th, 2017 massive protest held in Washington DC to oppose the inauguration of Trump and a request from the J20 Defense organization to sign a statement in support of those arrested. The demonstrators face up to 10 years in prison, and over 200 of them are challenging the charges and taking it to court to have them dropped. On July 27th, a judge will rule on a motion to dismiss the charges. With collective power across the country, the Judge will be more likely to rule in the defendant's favor if she sees strong public support. After the statement was read, Friends expressed concern about the militant nature of some of the language while recognizing the concerning issues this statement signals about the increasing moves at the federal level and in many localities to eliminate the freedom to protest. There was not a sense of the meeting on signing the statement; individuals were encouraged to pursue their own letters on this concern.

Friends read a sign-on letter (attached) for leaders of any faith, denomination, or spiritual practice from the Coalition Against the Pilgrim Pipelines to send to Governor Andrew Cuomo. Friends spoke of our earlier minute on this issue, and approved the Clerk signing on to this letter on behalf of the Meeting.

Treasurer's Report:

Unrestricted cash on hand as of July 6, 2017: \$9,341.92. The Madison Family fund payment will be going to the family this month. The report was approved.

Nominating Committee:

The second reading of the slate (see attached) was read and approved.

Maggy Wiard, Co-Clerk, read a letter from the Labor Religion Coalition inviting the Meeting to become a member congregation. Friends spoke of the many important advocacy and education events hosted by the Coalition. Friends agreed to bring this back to our September Meeting for Business.

Due to Easton Day on September 10, September Meeting for Business will be held on Thursday, September 14 at 6:30 p.m.

The Meeting closed with silent worship at 1:45 p.m.


The March for Justice is an undertaking by the Alliance of Families for Justice to bring to the attention of the New York State Legislative body, Governor and the general public human rights abuses in NYS prisons and jails. Some of the key issues the organization is pursuing are raising the age of criminal responsibility, increasing family visitation to prisons, meaningful reform of the use of solitary confinement, ending human rights abuses in NY's prisons and jails and closing Attica, meaningful reform of the parole system, and the Domestic Violence Survivors Justice Act Campaign.

Albany Culmination of the March for Justice (cont.)

The March For Justice, started in New York City Aug. 26, culminates with a major press conference and rally in Albany Sept. 13, the anniversary of the 1971 Attica uprising and massacre. 8/31-9/4, Solitary Housing Unit (SHU) Replica at Columbia Co. Fair Sponsored by Old Chatham Meeting



The SHU exhibit will be staffed by members of the meeting and associated volunteers. People in a SHU in NYS spend 22 to 24 hours a day locked in a cell the size of an elevator, alone or with one other person. Over 40% of all suicides in NY prisons in 2014 and 2015 took place in solitary, though only 9% of all people in prison are in solitary. The SHU is still used in New York State prisons despite a 2015 agreement NYS is implementing to reduce its use. 80,000 of the 2.2 million people currently incarcerated in the U.S. are in SHUs.
